Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services; and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability: Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEM-AP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEM-AP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEM-AP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS and SEM-AP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEM-AP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEM-AP troubled.

When allocating Project-Based vouchers, it is KHC's goal to select sites that provide for de-concentrating poverty and expanding housing and economic opportunities. KHC plans to allocate 35 project-based vouchers in Pulaski County to be utilized in 1 Recovery Kentucky Center.</p>

We have three additional families who have completed their counseling requirement and are currently in the process of securing loans for homeownership. • A maximum of 100 housing choice vouchers will be utilized by KHC to provide housing assistance to homeless veteran individuals and/or families; and eligible families who are transitioning from Continuum of Care funded Permanent Supportive Housing Programs. KHC is currently utilizing 41 vouchers to house homeless veterans. As of April 2017, KHC began accepting referrals for the Kentucky Moving on Program, however, currently no vouchers are being utilized for Kentucky Moving on Program. • KHC is allotted 38 VASH vouchers. KHC is successfully utilizing 26 allocated VASH vouchers. • KHC has 125 FSS participants and 85 with an escrow balance.
