# **Becoming a KHC-Approved Environmental Compliance Service Provider**

**Persons or companies who wish to be included on KHC's Approved Environmental Compliance Service Provider list must submit a qualifications package to KHC that includes the following:**

- Verification of familiarity with the requirements of 24 CFR 58.
- Verification of registration as Active and in Good Standing with Kentucky Secretary of State office ([www.sos.ky.gov](http://www.sos.ky.gov)).
- Resumes for all proposed personnel detailing educational qualifications, special recognitions, licenses, or certifications.
- Copies of previously completed environmental reviews demonstrating quality of work.
- Names and addresses of at least three (3) client references.
- Name and telephone number of individuals who is to be principal contact for KHC.
- Name of professional insurance carrier and amount of coverage carried.

Each qualifications package submission must include and address each of the above items. Failure to comply with these requirements will result in the response not being accepted.

## **Services Provided Must Include:**

- Performance of environmental reviews, primarily on multifamily projects as required by 24 CFR 58, to ensure a project's compliance with the following: a. National Historic Properties Act.
- Executive Order 11988 (Floodplain Management).
- Safe Water Drinking Act.
- Endangered Species Act.
- Wild and Scenic Rivers Act.
- Farmland Protection.
- Environmental Justice (EC 12898); and
- Other HUD environmental standards including but not limited to the review of Phase I environmental assessments.
- Provide public notice when necessary and appropriate.
- Require the implementation of mitigation measures when necessary, recommend appropriate measures and review to ensure the necessary measures were taken.
- Work with KHC's partners/applicants to ensure compliance with KHC's unidentified scattered site monitoring strategy.
